Be Safe: Get your Vaccination

Influenza is highly contagious and is spread from one person to another mainly by droplets when someone with the flu coughs or sneezes. The virus can live on surfaces for up to 48 hours. making it highly important that all hightouch areas, both at Saint Vincent's and at home, are cleaned daily. The most effective way to prevent influenza and/or severe outcomes from influenza is through vaccination and practicing good hand hygiene.

All of the residents at Saint Vincent's will be offered a high dose influenza vaccination which has been specifically designed for adults 65 years old and older. This vaccine is stronger and more effective than the regular vaccine offered to those under age 65.

All resident vaccinations will be complete by mid November. Vaccinations will be

offered to staff at various times

throughout the month. If staff have received a

vaccination elsewhere, let **Debbie Coombs** know at ext. 136 so that you can be included in our statistics and be entered to win a \$100 gift card to Sobey's.

Make sure you are washing your hands frequently with soap and water or alcohol based hand rub to help protect your loved ones and yourself.

In the spring of this year, The DHW gave us the funding to purchase new ovens for our kitchen. Our old "deck" ovens were 20+ years old and in need of replacing. After much research, two "combi" ovens were purchased this summer. The timing was perfect as we were already in the process of renovating our kitchen. These state of the art "combi" ovens (meaning combination convection and steam) are fully automated and programmable. They have the capability to fry, roast, steam, grill, poach and bake. They can set the temperature, humidity and cooking time and monitor the cooking climate and browning. Recipes can also be programmed into their data base, making cooking as simple as calling up that particular food item and pressing the button! The ovens can also be programmed to cook foods (such as roasts) overnight and hold the food at a warming temperature for slicing the following day. These ovens have significantly improved the quality of the meals we serve and the efficiency of the cooking process itself.



Memorial Service

On Thursday, November 29th we will host a Memorial Service to remember residents who have passed away. This semi-annual service provides residents, staff, volunteers and family members an opportunity to come together to collectively remember those who have died. Often there are close bonds formed with families and it allows everyone an opportunity to meet again. This service will take place at 1:30 pm in the Chapel. All are welcome.

Have you ever wondered why we have visitors sign in and out?

After a review of the practice it appears there isn't a great answer to this question. In the past 14 years there have only been a handful of times it was referenced and those were all before we installed our security system. We now have a video recording of all entries and exits.

With no significant purpose, the use of the sign-in book was discontinued.

In the News

It seems that long-term care issues have been in the news often over the last six months. The most recent topic was licensing; I offer the following as information on Saint Vincent's.

As a nursing home, we are licensed by the Department of Health and Wellness. Licensing inspections are completed by

an Investigation and Compliance Officer who measures against applicable legislation, policies and standards such as the Homes for Special Care Act

(1989) and the Long Term Care Program Requirements (2016). There are outcomes and specific requirements under the areas of fundamental requirements, resident care, administration, service quality, service continuity, information management, human resources management, and physical space.

There are usually two inspections per year, one announced visit in late winter and one unannounced visit in the fall. The officer does a walkthrough of the facility, reviews documentation and talks with residents, family members and staff.

Based on the results, directives are issued for deficiencies or non-compliance of the standards. We must submit an action plan before our license will be renewed; confirmation that action plans have been successfully completed must be provided.

We view the licensing process as a learning opportunity. It is reassurance for us that our policies and practices continue to allow for the provision of safe, quality care and service. We also voluntarily participate in accreditation
